

MONTH PROMOTION – TERMS & CONDITIONS

1. Promotion Overview

The Black Friday Month Promotion ("the Promotion") is an incentive campaign by Alliance Insurance Company ("Alliance") designed to reward new customers who take up qualifying insurance policies during the month of November 2025.

2. Promotion Period

- The Promotion runs from 1 November 2025 to 30 November 2025 ("the Promotion Period").
- All qualifying policies must be taken up within this period to be eligible for the rewards.

3. Eligibility

- 3.1 The Promotion is open to new customers who purchase any of the following policies during the Promotion Period:
- Funeral Insurance
- Legal Insurance
- Motor Insurance
- 3.2 To qualify, policies must be active, and the first premium payment must be received within the Promotion Period.

- 5.3 All standard terms and conditions of the Alliance Legal policy remain in effect and continue to apply.
- 5.4 The campaign is open to everyone, regardless of their method of payment (e.g., cash, stop order, debit order, etc.).
